



## **UBC MM Summer 2024 Study Abroad Opportunities**

Updated Jan 18, 2024

UBC MM students are encouraged to participate in a summer study abroad program following the completion of Period 5 and the Capstone. Most programs take place between June and August. Summer Study Abroad is completely optional for MM students. Summer Study Abroad opportunities are grouped into 2 categories below. Each category comes with variations in the application and approval process, as well as costs.

### 1) Robert H. Lee Graduate School Exchange Partner Summer Programs:

These schools require a 2-step application process. Firstly, MM students need to apply to the RHL Graduate School Office, using our on-line application via the Go Global. *Applications are due February 11, 2024*. We will review your application, and if approved, nominate you to the selected school. You will then be required to complete paperwork and course selection directly with the school.

Please look at the following schools carefully. Depending on the program, there may or may not be additional fees/expenses.

- 2. Exchange partners of the Robert H. Lee Graduate School, Sauder School of Business: Requires a 2-step application process. Firstly, UBC MM students need to apply to the RHL Graduate School Office/Go Global. We will review your application, and if approved, nominate you to the selected school. You will then be required to complete paperwork and course selection directly with the school.
- 3. **Please note**: Program Dates and costs can change. All dates and costs to be confirmed by participating students. In cases where there's a date and/or cost discrepancy between this document and the host school program website, the host school information will stand.
