BC Education System – By the Numbers

BC Public School System:

- Number of schools = 1600
- Number of students = 575,000
- Number of teachers = 43,000

BC Independent School System:

- Number of schools = 365
- Number of students = 86,000
- Number of teachers = 7,200

BC Offshore School System:

- Number of schools = 45
- Number of students = 12,500
- Number of teachers = 720

BC First Nations Band Schools:

- Number of schools = 120
- Number of students = 5000**Federally regulated**





BC Regulatory Structure

Supported by the *Teachers Act* which received Royal Assent on November 14, 2011 and came into force on January 9, 2012.


Ministry Teacher Regulation Staff

- Vancouver Office, Ministry of Education: 60 employees.
- Operationalizes the regulatory structure by providing support to the BCTC, Commissioner, DPCB, DOC and ISTCSC.
- Provides advice/ information to teachers, education stakeholders, parents and the public regarding teacher certification, teacher discipline and the Standards of Education in BC.





Standards within BCTC Purview



Professional Standards

Conduct and competence required for an individual to be issued and maintain a BC teaching certificate.

Teacher Education Program Approval Standards

Requirements a program must meet to be approved by the BCTC in order to recommend grads for certification.

Certification Standards

Training/education/qualifications an applicant must have to be eligible for a BC teaching certificate.

Professional Standards for BC Educators

Format:

 Nine statements of principle contain brief descriptors that speak to a degree of excellence

Purpose:

- Serve as the hallmark of the profession
- Articulates the work of educators
- Outline the conduct and competence required to be issued and maintain a teaching certificate in BC

The new Professional Standards #9

 Included in the release of the revised Standards for BC Educators is a new 9th Professional Standard specific to Truth and Reconciliation and the history of First Nations, Inuit and Métis in Canada.

9

Educators respect and value the history of First Nations, Inuit and Métis in Canada and the impact of the past on the present and the future. Educators contribute towards truth, reconciliation and healing. Educators foster a deeper understanding of ways of knowing and being, histories, and cultures of First Nations, Inuit and Métis.

Educators critically examine their own biases, attitudes, beliefs, values and practices to facilitate change. Educators value and respect the languages, heritages, cultures, and ways of knowing and being of First Nations, Inuit and Métis. Educators understand the power of focusing on connectedness and relationships to oneself, family, community and the natural world. Educators integrate First Nations, Inuit and Métis worldviews and perspectives into learning environments.
