
# 2014 Competition Fact Sheet



## 2014 Competition Timeline



#### First Round

- Competitors build and analyze a full valuation model based on discounted cash flows, trading comparables and precedent transaction analysis
- MBA teams will be required to complete additional transaction analysis on the company
- Competitors submit a complete pitchbook presentation, financial model and memorandum for evaluation

#### Second Round & Final Round

- Competitors prepare advice on a realistic transaction and deliver live pitches to investment bankers
- Competitors receive advanced tools including a complete financial model, comparables set and commercial termsheet
- Finalists pitch to Managing Directors of leading North American investment banks in front of 300 students and 150 professionals during the Conference
