

UBC MM Summer Study Abroad Opportunities – Summer 2020

UBC MM students are encouraged to participate in a summer study abroad program following the completion of Period 5 and the Capstone. Most programs take place between May and August. Summer Study Abroad is completely optional for MM students. Summer Study Abroad opportunities are grouped into three categories below. Each category comes with variations in the application and approval process, as well as costs.

1) Robert H. Lee Graduate School Exchange Partner Summer Programs:

These schools require a 2-step application process. Firstly, MM students need to apply to the RHL Graduate School Office, using our on-line application via the Go Global. **Applications are due January 20, 2020.** We will review your application, and if approved, nominate you to the selected school. You will then be required to complete paperwork and course selection directly with the school.

Please look at the following schools carefully. Depending on the program, there may or may not be additional fees/expenses.

For these programs, you first need is to get our permission and then apply directly to the university offering the program meeting their specified deadlines. 1. **Student-Researched Summer Programs (LSE and Harvard Summer School):** Application made directly to the summer school. Must inform RHL Graduate School Office for course approval and recognition.
2. **Exchange partners of the Robert H. Lee Graduate School, Sauder School of Business:** Requires a 2-step application process. Firstly, UBC MM students need to apply to the RHL Graduate School Office/Go Global. We will review your application, and if approved, nominate you to the selected school. You will then be required to complete paperwork and course selection directly with the school.
