Application Information for Spring & Summer Programs

Most of the above programs are offered by official exchange partners of the Robert H. Lee Graduate School, Sauder School of Business. UBC PMBA students, if selected to participate by the RHL Graduate School, do not pay tuition for these programs. Other expenses are the responsibility of the attending student.

Exchange Partner programs: Requires a 2-step application process. Firstly, UBC MM students need to apply to the RHL Graduate School Office/Go Global, including the payment of an exchange Application fee of \$415.00. We will review your application, and if approved, nominate you to the selected school. You will then be required to complete paperwork and course selection directly with the school.
