UBC IMBA students, if selected to participate by the RHL Graduate School, do not pay tuition for these programs. Other program fees and expenses are the responsibility of the attending student.

Exchange Partner programs: Requires a 2-step application process. Firstly, UBC IMBA students need to apply to the RHL Graduate School Office/Go Global. We will review your application, and if approved, nominate you to the selected school. You will then be required to complete paperwork and course selection directly with the school.
