COURSE DESCRIPTION

BA 515 is an introduction to business analytics and technology with two goals. The first is to introduce the fundamental concepts of analytics and technology platforms (e.g., big data, mobile, cloud, AI, machine learning) and their implications to business and industries. The second is to provide hands-on programming experiences to acquaint students with Python programming language and its rich ecosystem for data processing, data visualization, and text analytics.

COURSE FORMAT

Class time will be used for a combination of lectures, live programming, and discussions. Attendance is expected to accomplish the learning objectives below. Lectures and discussions will assume that students having pre-read the corresponding materials as listed in the course schedule.

LEARNING OBJECTIVES

By the end of this course, students will be able to:

- 1. Understand the concepts of data analytics and the implications to business
- 2. Understand the technology platforms and their implications to business
- 3. Have coding literacy with hands-on experiences on Python programming
- 4. Have data literacy with basic data visualization and text analytics in Python

Details of Assessments

DataCamp Assignments (20% = 2 x 10%)

Learning programming requires a lot of hands-on practices. To provide a rich practice environment, you will be provided a free, unlimited access to DataCamp for 6 months. You will be assigned to complete two courses: Introduction to Data Science in Python and Data Science for Business. You are free to explore other DataCamp courses outside this class.

Group Project (25%)

Book Review (20%)

Among the <u>recommended list</u>, you will select a book, read it, and write a book review. The following questions can be the guideline of your book review: Why did you select this book? Write a brief summary of the book. What did you learn from the book? Did you get a new idea from this? See Canvas for the more detailed rubrics.

Exam (25%)

There will be a final exam at the end of the course. You are responsible for everything that is covered in the classroom, including additional materials discussed in class. The exam will consist of multiple-choice questions. For some questions, students are expected to write codes based on the specifications.

Class Participation (10%)

Effective class participation includes: (1) solving questions during the lecture, (2) asking significant questions, (3) sharing your point of view with the class, and (4) building on points raised by others. The participation can be either in lecture or in Piazza (the online Q&A platform we use). Note that office hour visits are not counted as course participation. Piazza allows students to post questions (publicly, anonymously, and privately) and to answer questions from the peers. Providing thorough and clear answers and ideas on the Piazza discussion board will be considered when calculating your participation grade. We will consider both quantity and quality of the class participation. Instructor team does not accept course-related questions via emails, so please post your questions on Piazza.

An "adequate acknowledgement" requires a detailed identification of the (parts of the) code reused and a full citation of the original source code that has been reused.

Students are responsible for ensuring that any work submitted does not constitute plagiarism. Students who are in any doubt as to what constitutes plagiarism should consult their instructor before handing in any assignments.

Attendance

Excepting extenuating circumstances, students are expected to attend 100% of their scheduled class hours. To help replicate the classroom experience, make sessions more dynamic and hold each person accountable, both students and instructors are required to have their <u>cameras on during Zoom sessions</u>.
