Other program fees and expenses are the responsibility of the attending student.

**Exchange Partner programs**: Requires a 2-step application process. Firstly, students need to apply to the RHL Graduate School Office/Go Global. We will review your application, and if approved, nominate you to the selected school. You will then be required to complete paperwork and course selection directly with the school.
