

IMBA Class of 2024 Tuition Fees

The total tuition fee for the IMBA program (Class of 2024): **\$71,145 USD**

Students are required to select their currency of choice at the start of the program and use **only that currency** for all deposits and tuition payments throughout their program.

- Late payments or other indebtedness to the University will result in your student record being withheld and interest charges being assessed.
- Late payments or other indebtedness to the University will result in your withdrawal from modules and the inability to continue with your IMBA studies.

Payment Methods

3. Students paying by wire transfer **MUST** send copies of bank documentation confirming the amount in **USD** and date of payment to the UBC IMBA Shanghai Office.
4. Money order or certified cheque **in USD**, issued by a Canadian bank **or** a foreign bank to its Canadian branch only (i.e. Bank of China to Bank of China Head Office in Toronto to pay UBC). Money orders or certified cheques must be made payable to **UBC Sauder School of Business**. Please note that **NEITHER** personal cheques **NOR** travel cheques are accepted.

Please note that students are responsible for their own bank service charges when making payments by credit card, wire transfer, money order or certified cheque.

If students wish to change the currency for the second payment (i.e. from USD to RMB or from RMB to USD), please note that there is a **\$500 USD** administration fee.

Refund Policy

If students withdraw, or are required to withdraw, for any reason (including failure), tuition will be refunded according to the following schedule (Pacific Standard Time):

Tuition Deposit \$4,000 USD is non-refundable and may not be transferred to another student or another year's admission.

- Withdrawal **prior to the end of December 31st 2022**, refund will be \$10,000 USD or ¥75,000 RMB.
- Withdrawal **between January 1st 2023 and the end of January 31st 2023**, refund will be \$5,000 USD or ¥37,500 RMB.
- Withdrawal **on or after 12am February 1st 2023**, there will be no refund.

Refunds will be made in the currency used for payment.

Tuition Fee

Students must pay their tuition fees before the deadline to avoid incurring financial hold and interest charges. Students who are in arrears to the university will not be able to register in any courses, make changes to existing registration, nor will they be able to access official transcripts. Financial penalties also apply for students in arrears.
