

Should you cite in these cases?



- I looked at different websites (or articles, books, etc.) just to get ideas
- 2. I refer to information that would be known to my readers (aka "common knowledge"), e.g., "WWII started in 1939."
- I used ideas from a source, but I put them in my own words.

Reminder: Acceptable paraphrase

- ► Has reporting expression (or name in citation) AND page number
- ▶ Is 100% in your own words <u>and</u> sentence structure
- Accurately represents the original

Acceptable or Unacceptable Paraphrase?

- Original:
- What saved Sienkiewicz-Mercer from languishing in the institution was her ability, using very limited means, to connect with those around her.
- ► The only thing that prevented her from languishing in an institution was her ability to connect with people around her by using nothing but eye movements (Couser 42).



Acceptable or Unacceptable Paraphrase?

Original: [Autobiography] can personalize and humanize categories of people whose experiences are frequently unseen and unheard....make powerful interventions in debates about social justice, sovereignty, and human rights. [Whitlock 3] ▶ Life narratives have the power to promote public awareness regarding important global issues that may go unnoticed by the international community (Whitlock 3).



Are these cases of academic misconduct?

- ► I listed all the sources I used in my paper at the end, in my Works Cited, but I didn't always use in-text citations.
- My mom read my paper and fixed my grammar.
- My mom read my paper and gave me some feedback.
- ▶ I included a sentence from a source but used a thesaurus to change the words. I did include a page number and reporting expression.
- My prof said not to use Wikipedia, so I didn't cite it (though I used it anyway).
- ▶ I cited a source I read about in another article but didn't read.



Problems & solutions

- ▶ I guess I didn't put quotation marks around that phrase in my notes, so I didn't know I was using the words from the original.
- ▶ I had so many tabs open on my desktop that I was sure who said what.
- ▶ I didn't know how to cite [various sources]
- ▶ I had 3 papers due in 24 hours and I was really stressed out.
