TRUST BASED PHILANTHROPY

In Practice

Flexible Funding: provides organizations with the freedom to allocate resources based on their immediate needs and priorities without strict limitations or specific directives on how the money should be spent.

Operational Funding: empowers organizations to strategically plan for a sustainable future by retaining and paying for staff wages and other costs.

Oral Applications: organizations with limited capacity often find oral applications more accessible, as they alleviate the need for lengthy and extensive written submissions.

Grassroots Organizations



Grassroots organizations face vulnerability within the charitable sector because funders wield decisive power regarding financial support. This power imbalance leaves grassroots organizations susceptible to pressures of opinions, perspectives and decisions of funders.







Funders: Endowment Model

"We are a foundation and we started with an endowment, and over 80 years that endowment has grown to a very large amount. And so the returns from that investment, a lot of that is the money that we're able to grant out."

Funders: Endowment Model



Charitable Status

A registered charity is an organization that has been granted charitable status by the Canada Revenue Agency (CRA) and operates exclusively for charitable purposes and activities. A charity has registered charitable purposes that must relate to the four broad categories of charitable purposes as defined by the CRA:

When individuals or entities contribute financially to a registered charity that is tax deductible which is why it is referred to as charitable dollars.

Tax receipts issued by registered charities allow donors to receive tax credits, which incentivizes donations to charities over nonregistered non-profits.
