

The same Rumana, who always believed in celebrating life. She started her career as a lecturer in International Relations but after becoming blind, decided to change her career. Rumana graduated from the University of British Columbia, Canada in May 2017 with a law degree. She also has a Masters degree in political science from UBC. Currently she is a counsel at the Department of Justice Canada in Vancouver. Today Rumana is a beloved lamp-lighter who instills light and love wherever she goes and speaks.
