- Completing due diligence packages, financial analysis, social and environmental analysis for selected social ventures
- Presentations for analysis, social venture sourcing, and due diligence
- Legal and financial decision making on short listed companies
- Active participation and discussion in Investment Committee meetings and decision for final investment
- Management of portfolio post-investment

Position Requirements

- Students selected are able to spend an average of 5 hours per week working with their 10th Avenue Fund Student Team
- Space will be provided at UBC to complete individual and team-based work
- Weekly meetings with the Helder Venture team and local professionals to gain insights and advice on each stage of the investment process
