This course will explore treatment challenges and perspectives for the growing older population. There is a gap between what clinicians have been taught during training and recent findings on the trajectory of aging in our society. As a result, clinicians need to be updated on the latest advances in order to best serve the needs of their patients. By understanding the dynamics of the aging process clinicians will improve their competence and their ability to treat patients from mid-life to older age. **Learning Objectives:** Upon completion of this course you will be able to: outline steps for achieving successful aging, including mind/body techniques and mindfulness meditation; identify the cognitive and developmental components of aging as well as recognize denial of the aging process; determine the psychotherapeutic needs of patients who are depressed, hoarders, physically ill, and/or who are in physical pain; offer suggestions for working with different types of problems including sexual issues, relationship problems, and family dynamics; and develop strategies to handle end of life questions and legal issues. This course is intended for all health and mental health clinicians, educators, researchers, and others interested in the aging process.
