Flights	The FT MBA February exam period will end on Thursday, February 9 th , 2023 at 10 PM. Do not book flights until after the exam period is completed. International flights require passengers to arrive 2-3 hours before departure; therefore, flights leaving before midnight on February 9 th , 2023 will not be an option. Missed exams will not be re-scheduled.
	Be sure to purchase tickets that arrive on location by Sunday Feb 12 th . Your ticket to the destination should be for the duration of the program. The program will start on Monday Feb 13 th and the <u>last</u> program day in location will be Friday, February 24 ^h , so you can depart anytime from Saturday, February 25 th . FT MBA students must return to Vancouver before Period 4 begins at 8:00 AM on March 6 th , 2023.
	We highly recommend purchasing trip Cancellation and Interruption Insurance and flexible airfare. In the event of a medical emergency, illness, travel advisory from the Canadian Government not recommending any travel, or natural disaster, you could be refunded for some/all of your flight purchase. The type of coverage may vary depending on the policy you choose to purchase. The cost is often determined by the price of your ticket and may range between \$100 – \$150 CAD.
Hotel	Due to the logistical challenges and safety requirements students on GIE will stay at the same hotel in each destination. Booking information will be made available by the RHL Office. You will be notified of the details and costs in the upcoming weeks.

Steps of Application

Tourist Visa Online Application Process:

- 1. Visit the following link: https://tramites.minrel.gov.cl/
- 2. Set your language preferences to English by clicking the British flag in the top right corner of the screen
- 3. Click "Visa Application"
- Fill in ALL required information and upload documents (if you do not provide all required information, your application will be VOID and will not be processed).

- 5. Submit your application and save your username and password for the SAC (online visa application) system you will need them to check your visa status.
- 6. Ensure that you keep all of the originals of the documents submitted electronically, as you will need to bring them to your appointment once your visa is approved. You can check the application status in this link:

7. Call the Chilean Consulate to arrange an appointment (604 681 9162 or 604 683 9181) to pick up your visa. Bring the originals of all the documents uploaded in your application to your appointment. Please note that you will be required to provide thumbprints and your signature at the appointment. ALL visas must be picked up by appointment in person.

Processing Time & Cost

- Costs of the Visa may vary from country. You can check the information regarding costs here:

- For India the cost of the Visa is around \$42 US. For Kyrgyzstan \$36US and for Nigeria \$200US.
- The Visa is valid for up to three months from the date of issue.
- Please be sure to allow sufficient time to apply for the visa in addition to the visa processing time.
