	The FT MBA P3 February exam period will end on Thursday, February 9 th , 2023 at 10 PM. Do not book flights until after the exam period is completed. International flights require passengers to arrive 2 hours before departure; therefore, flights leaving before midnight on February 9 th , 2023 will not be an option. Missed exams will not be re-scheduled.
Flights	Be sure to purchase tickets that arrive on location by Sunday Feb 12 th . Your ticket to the destination should be for the duration of the program. The program will start on Monday Feb 13 th and the last program day in location will be Friday, February 24 ^h , so you can depart anytime from Saturday, February 25 th . FT MBA students must return to Vancouver before Period 4 begins at 8:00 AM on March 6 th , 2023.
	We highly recommend purchasing trip Cancellation and Interruption Insurance and flexible airfare. In the event of a medical emergency, illness, travel advisory from the Canadian Government not recommending any travel, or natural disaster, you could be refunded for some/all of your flight purchase. The type of coverage may vary depending on the policy you choose to purchase. The cost is often determined by the price of your ticket and may range between \$100 – \$150 CAD.
Hotel	Due to the logistical challenges and safety requirements students on GIE will stay at the same hotel in each destination. Booking information will be made available by the RHL Office. You will be notified of the details and costs in the upcoming weeks.
Visa Requirements & Type	Some foreign nationals require a Schengen (short-stay, Type C) Visa to enter Spain, which is valid for stays in Spain and other Schengen States* for up to 90 days. Citizens of the EU, EEA member states, Canada, the United States, and several other countries (see link below) do not need a visa to enter Spain. A complete list of citizenships that require or are exempt from the Schengen visa can be found here . The applicants of Schengen visas or tourist visas living in British Columbia can process their visa applications for Spain at
	the Consulate General of Switzerland in Vancouver. More information HERE Schengen visa for a stay of up to 90 days For persons wishing to enter Spain for a short stay of up to 90 days within a 180-day period: for example, in a context of tourism, a visit to relatives or friends, short-term language studies, participating in a
	conference or in sporting/cultural events, etc.

Individuals exempt from the <u>Schengen Visa</u> (eg. EU, Canadian, and American citizens) must travel with a passport that valid for at least 3 months after exiting Spain (or any Schengen state that they are visiting).
