This site provides access to criminal justice data, articles and books. Content is not produced by NACJD, but is deposited by external agencies, such as the Bureau of Justice Statistics, the Census Bureau and the Bureau of Justice Assistance. Also provides access to data resource guides on an array of topics, including capitol punishment, homicide, violence against women, correctional facilities, crime victimization and much more.

Banking/Economy/Trade

A branch of Industry Canada devoted to supporting the adoption, use and development of ebusiness and its continued growth in the Canadian economy. Provides links to information on international policy, statistics and research in this area. Also provides full-text access to its publications.

From the Government of Canada site, this particular webpage provides links to a summary of major economic events in Canadian history, from 1670 to present. Also provides information about the context and impact of each event on the Canadian economy.

OCA monitors the financial status of the CPP, Old Age Security (OAS) program and federal public sector employee pension and insurance plans. The site links to its actuarial reports and studies. Report topics include Canada Student Loan Program, and the pension plans for Canadian Forces, Members of Parliament and the RCMP. The actuarial studies contain many statistical tables.

Office of the Superintendent of Bankruptcy Canada:

http://www.ic.gc.ca/eic/site/bsf-osb.nsf/eng/home. OSB is a special operating agency associated with Industry Canada mandated to "protect the integrity of the bankruptcy and insolvency system." Provides information, publications and statistics relating to bankruptcyas well as national insolvency rates as well as economic analyses of the rates. Also has a database of bankruptcy and insolvency records.

WTO Regional Trade Agreements Information System:

You can retrieve information by WTO member or criteria and you can find a list of all RTAs currently in force, early announcements and pre-defined reports.

Research focuses include: Aboriginal issues, criminal justice issues, drug addictions, family violence, governance, human rights, organized crime, sentencing, terrorism and security.

It pays special attention to combating transnational organized crime, money laundering, drug control, corruption and illicit trafficking in human beings." Links to its own documents & reports as well as external links to (official) sources of related statistics.

This survey is sent to countries and regional governments around the world to "collect data on the incidence of reported crime and the operations of criminal justice systems." Results are available for download, though the most recent, fully complete survey is 2001/2002.

Open CRS: http://opencrs.com/. This site was created and is maintained by a division of the Center for Democracy & Technology. Its purpose is to act as a portal site to Congressional Research Service (CRS) reports, which are not directly made available to the public despite being tax-payer supported. Provides a single interface to search multiple collections and subject browsing.

Infrastructure/Services

Infrastructure Canada departments contribute to rural and urban infrastructure, and make sure that Canadian roads, bridges, railroads, water systems, transit, waste management systems, ports and airports are well-built and maintained, safe and secure. Provides links to major infrastructure programs and to the Research Gateway - a web portal highlighting resources "on infrastructure, cities and communities issues."

Service Canada: http://www.servicecanada.gc.ca/eng/home.shtml. Federal government portal to government programs and services. Major focus on Aboriginal Peoples, Families & Children, Immigrants, Seniors, People with Disabilities, Veterans, Employers & Students. The site provides full-text access to its publications/reports - which includes access to its public opinion research - as well as online forms, news releases, FAQ, and a directory of all Service Canada locations.



Science

This site is a portal to science information, programs/activities, and publications. Major themes are science education, scientific advice & governance, women and science and science & social action. Highlight publications are freely available to download as pdf files.

An NGO dedicated to warning "the public and policy leaders of potential dangers from scientific and technical advances and to show how good policy could increase the benefits of new scientific knowledge." The site provides access to FAS publications, news, reports, and its collection of *Congressional Research Reports*.

Hydrogen Economy Portal: http://www.ussc.gov/. A gateway to information on Canadian hydrogen and fuel cell initiatives." Provides information on success stories, the basic science and applications of hydrogen and fuel cell technologies, research organizations and researcher activities and also links to its publications and external resources.

National Science Foundation Science & Engineering Statistics:

Also provides links to NSF Institute for Social, Behavioral and Economic Sciences. Publications are keyword searchable or browsable by subject.
